NARRATIVE: SUBJECT: LEE, KARI M. 26 YOA OF 0-99 BLOCK OF S. PARKSIDE IN CHICAGO, IL WAS ARRESTED, CHARGED WITH POSSESSION OF A CONTROLLED SUBSTANCE, MANUFACTURE OF CONTROLLED SUBSTANCE, AGGRAVATED UNLAWFUL USE OF WEAPON, AND CRIMINAL TRESPASS TO MOTOR VEHICLE. SUBJECT WAS OBSERVED EXITING FROM A 2007 BLACK JEEP LIBERTY THAT WAS DRIVEN AND PARKED IN THE WEST LOT OF OAK PARK RUSH HOSPITAL WITH SEVERE FRONT END DAMAGE (INVOLVED IN TRAFFIC CRASH AT 400 BLOCK OF MADISON). SUBJECT BEGAN YELLING FOR HELP STATING HE HAD BEEN SHOT IN HIS LEG AND WAS TAKEN INTO THE EMERGENCY ROOM FOR TREATMENT. OFFICERS ARRIVED AT HOSPITAL, AND SUBJECT GAVE SEVERAL CONFLICTING STORIES AS TO WHERE HE HAD BEEN SHOT. AS INVESTIGATION CONTINUED SUBJECT WAS FOUND TO BE IN POSSESSION OF A LARGE QUANTITY OF NARCOTICS (113 BAGS OF SUSPECT HEROIN 83GRAMS) ON HIS PERSON, AND THE VEHICLE SUBJECT WAS DRIVING WAS FOUND TO BE STOLEN OUT OF CHICAGO (07JAN22 FROM 5000 BLOCK OF ADAMS JF-105837). ADDITIONALLY, A FIREARM WAS LOCATED ON THE DRIVERS SIDE FLOOR OF THE VEHICLE. SUBJECT WAS TREATED AND RELEASED FROM HOSPITAL FOR A GUN SHOT WOUND TO HIS LOWER RIGHT CALF AND FOOT. OAK PARK POLICE INVESTIGATION RESULTED IN THE COOK COUNTY STATES ATTORNEY APPROVING CHARGES ON 14MAR22 FOR AGGRAVATED UW. SUBJECT WAS ADDITIONALLY CHARGED WITH THE NARCOTICS AND CRIMINAL TRESPASS TO VEHICLE. SUBJECT WAS ON PAROLE FOR AGGRAVATED BATTERY A POLICE OFFICER, AND ILLINOIS DEPARTMENT OF CORRECTIONS ISSUES A PAROLE VIOLATION WARRANT FOR SUBJECT. SUBJECT WAS PROCESSED AND HELD FOR BOND HEARINGS.
