ON 28JAN22, WEDGE (WEST SUBURBAN DRUG AND GANG ENFORCEMENT) WORKING WITH MCAT LOCATED VICTIM'S VEHICLE IN THE 5900 BLOCK OF IOWA AVE, WITH VICTIM DECEASED INSIDE OF VEHICLE. DUE TO THE VICTIM FOUND DECEASED IN THE CITY OF CHICAGO, THE INVESTIGATION WAS TAKEN BY CHICAGO POLICE (REPORT #JF-127113). THE INVESTIGATION REVEALED THAT THE VICTIM WENT INTO THE RESIDENCE OF RICHARD CHAVEZ ON 23JAN22 WHERE THE HOMICIDE OCCURRED. ON 24JAN22, THE OFFENDER MOVED THE VICTIM AND THE VICTIM'S VEHICLE TO THE 5900 BLOCK OF IOWA WHERE IT WAS DISCOVERED ON 28JAN22. RICHARD CHAVEZ WAS CHARGED WITH FIRST DEGREE MURDER ON 19FEB22 AND IS CURRENTLY IN CUSTODY IN COOK COUNTY JAIL.
